C.L.U.B., the Town of Pima, its members, agents, employees and servants (hereinafter referred to as "releasees"), in connection with any and all loss or damage and/or any claim or demand on account of any injury to the person or property or resulting in the death of the releasors, whether caused by the negligence of releasees or otherwise while participating in the Pima Public Library L.E.G.O. C.L.U.B. and related activities at the Pima Public Library.

I hereby agree to waive any and all past, present and/or future claims of whatever kind and of whatever nature, against releasees pertaining to any activity or conduct in which they may engage in connection with my participation in the Pima Public Library L.E.G.O. C.L.U.B. and related activities at the Pima Public Library. I agree not to hold releasees responsible for any loss, damage and/or injuries of any kind and of whatever nature I might incur during my participation in the Pima Public Library L.E.G.O. C.L.U.B. and related activities at the Pima Public Library, and I agree to hold them harmless, release, indemnify, defend and hereby forever surrender the right to recover any losses, damages or seek any other relief arising out of or in connection with any of my participation in the Pima Public Library L.E.G.O. C.L.U.B. and related activities at the Pima Public Library.

I AM AWARE OF THE INHERENT RISKS INCLUDING CHOKING HAZARDS, ASSOCIATED WITH LEGO'S, AND AM WILLING AND ABLE TO ACCEPT FULL RESPONSIBILITY FOR MY OWN SAFETY AND WELFARE IN CONSIDERATION FOR THE RIGHT TO PARTICIPATE IN THE PIMA PUBLIC LIBRARY L.E.G.O. C.L.U.B. ACTIVITIES.

I have carefully read this Assumption of Risk and Absolute Release of Liability (hereinafter referred to as "Release") and acknowledge that I understand it. This Release shall be governed by the law of the State of Arizona. If any portion of this Release is held to be invalid, the rest of the document shall remain in full force and effect.

I have read this Release in its entirety. I am aware of the circumstances of the activity in which I and/or my child/ward will participate. I give my full and complete permission for him/her to participate in the activity.

I agree to be bound, and I understand that in signing below I will be bound, by all of the terms of this Release and declare that all of the above statements are true, correct and complete. I acknowledge that I have read and understood this Release and that I sign it voluntarily.

I ACKNOWLEDGE THAT IN SIGNING THIS RELEASE THAT I RELEASE ALL LIABILITY AND WAIVE ANY RIGHT THAT I MAY HAVE ON BEHALF OF MYSELF AND/OR MY CHILD/WARD, MY/HIS/HER PERSONAL REPRESENTATIVES, SUCCESSORS, ASSIGNS, HEIRS AND NEXT OF KIN TO BRING ANY LEGAL ACTION OR ASSERT ANY CLAIM FOR ANY DAMAGE, INJURY AND/OR LOSS OF ANY KIND IN CONNECTION WITH HIS/HER PARTICIPATION IN THE PIMA PUBLIC LIBRARY L.E.G.O. C.L.U.B. AND RELATED ACTIVITIES AT THE PIMA PUBLIC LIBRARY.
